Overview

AAHA is hosting a two (2) day training that will provide attendees with the resources and tools that Tribes and TDHEs can utilize to prepare for and be "audit ready" for the annual audit of their Financial Statements and Single Audits. Some of the topics that will be covered include; an overview of requirements for a Single Audit, review of the latest OMB Compliance Supplement for the NAHASDA program, Audit preparation for grants, and an overview of the auditor requirements. It will also cover year-end closing processes which will include important topics such as; how to prepare a year over year revenue and expense analysis, review financial statements of Net Position and Revenue & Expenses, overview of accrual and modified accrual basis of accounting grants management and auditee responsibilities for findings and questioned costs. Attendees are encouraged to bring a copy of their audited financial statements.

Trainer

Marcie Sherer has over 30 years of accounting and management experience in various positions ranging from Staff Accountant to CFO, and has worked in the education, non-profit, tribal, and governmental arenas. She has over 14 years of housing related accounting experience and has direct experience in accounting systems, internal controls, financial reporting, financial audits, and preparing the Management Discussion and Analysis.
