EPIC Workshop

May 1, 2018 in Juneau, AK

Overview

Starting May 1, 2018, submission of the 2019 Indian Housing Plan/Annual Performance Report (IHP/APR) will be through the new EPIC on-line web reporting system or the Adobe fillable PDF version of the IHP/APR with an approved waiver.

On May 1, 2018, the Alaska Office of Native American Programs (AONAP), in conjunction with the Tlingit-Haida Regional Housing Authority (THRHA), is offering a workshop for the new EPIC reporting system for the IHP/APR in the THRHA's conference room located at 5446 Jenkins Drive, Juneau, AK. A total of 30 seats are available for the EPIC workshop. The workshop will begin with attendee sign-in and computer setup from 8:30 to 9:00 AM with class beginning at 9:00 AM. HUD staff will present the system in detail and walk attendees through the EPIC reporting process with a break at 12:00 for lunch. After lunch, attendees are invited to return and work on their 2019 IHPs or receive individual training. HUD Staff will be available to answer questions or assist in troubleshooting problems while attendees input their IHPs into the system. Even if the 2019 IHP is not ready, attendees can bring their 2018 IHP and enter it into the system for practice and to further familiarize themselves with the tools of the reporting system until 4:00 PM. The afternoon time is optional for attendance if early travel arrangements are necessary for attendees.

All attendees must **pre-register** to attend this course and sign up for EPIC access. Registered attendees will be sent instructions on how to request a user identification in Secure Systems for EPIC access. This must be completed prior to the course. Attendees need to bring a laptop computer with wireless capability or a tablet with Internet Explorer (version 11 or higher) already installed to access the EPIC system during the training. Only one computer or tablet is needed per IHP, so if two or more people are attending for the same entity, one computer can be shared during the workshop. Attendees will also need their approved 2018 or draft 2019 IHP to enter into the EPIC system as part of the workshop.
